JUDGING CRITERIA

Our judges will review each entry against the following six criteria:

- Originality, Creativity & Intent
- Functionality & Technical Qualities (how well does it work?)
- Ease of Use & Adoption (impact on end-user experience)
- Game-changer (potential impact in category and industry)
- Implementation & Performance (go-to-market strategy and entries with track record will be rewarded)
- Sustainability & Potential for Growth (sound business model and market opportunity)

A five-point scale will be used:

1. Questionable - Nothing new
2. Marginal work - Minor contribution
3. Solid work - Some contribution
4. Pioneering - Noteworthy contribution
5. Trailblazing - Major contribution

Judging Process:

Judges will read and score all entries in the given category, considering any supporting materials submitted. All judges' scores will then be combined and the highest scoring entries will determine the shortlist and winner for each category. Where there is a tie, judges will be asked to re-submit scores for the relevant entries.

- Have you formed an industry-wide collaborative effort to improve or guide the industry?
- Are you at the forefront of utilising the positive effects of industry collaboration?



BEST PROJECT OUTCOME

The category for organisations which have completed an industry leading project

- Have you delivered an industry-leading project which delivered markedly better results?
- Did the project you completed in 2021 or 2022 include industry-firsts that resulted in better outcomes?
- Is your project a trailblazer which shows new industry best-practices?



CHAMPION INTEGRATED WELL SERVICE COMPANY

The category for well service and vessel providers who offer the best-in-class options to the industry

- Does your organisation provide multiple services throughout project or campaign lifecycles?
- Can your business units support operators in an ongoing capacity or from the inception to completion of projects?
- Have you got proven business cases or results which show how your organisations involvement results in operational, tooling, equipment or capital savings?



DIGITAL TRANSFORMATION LEADER

The category for organisations which are trailblazers in digitising processes or solutions

- Has your organisation digitised an internal process or implemented a digital solution to improve company-wide efficiency?
- Is your organisation providing digital solutions which aid operators and large well service providers in offering or achieving better outcomes?
- Have you designed an innovative digital offering which brings the well intervention industry into the 21st century?

ENVIRONMENTAL SUSTAINABILITY INNOVATION

The category for organisations who are looking to the future with a keen eye on achieving more sustainable and environmentally friendly outcomes

- Is your organisation researching, planning or implementing measures to ensure a more sustainable future?
- Are there company-wide efforts to support less environmentally damaging practices?
- Is your organisation measuring how sustainable and environmentally friendly their projects or solutions are?
- Has your organisation set-up business units to support the net zero transition?



MOST INNOVATIVE SOLUTION

This category is for all our well service companies who have created original technologies or solutions to support their clients

- Has 2021-2022 seen the launch of your organisation's game-changing technology?
- Have you created a proven business case for the use of your latest innovative solution?
- Is your innovation delivering better project or campaign results for your clients?
- Are you helping solve well intervention challenges with your latest technology?



PLUG AND ABANDONMENT EXCELLENCE

This category is for organisations who have a solution, technology or completed a project which signifies the best in P&A or decommissioning

- Have you created a product, technology or solution which increases the safety or efficiency of P&A projects?
- Have you completed or are you in the process of completing a P&A/decommissioning campaign which offers better benefits for operators?
- Is your organisation eliminating common challenges or pain points which generally arise when planning or completing the P&A or decommissioning of wells?



SIGNIFICANT CONTRIBUTION TO THE INDUSTRY

This category is for professionals or organisations which have contributed to the well service industry throughout their careers or from their inception

- Are you a prominent professional within the industry whose colleagues would consider a subject matter expert?
- Have you accomplished a plethora of achievements throughout your career in well intervention?
- Would the well intervention industry look differently without the invention of your organisation's solutions or services?

FAQ's

Can I submit the same entry to numerous categories?

Yes! You can submit the same submission to numerous categories, however we would recommend editing your awards submissions form so it's specifically applicable to the given category

Does my submission need to revolve around a project/ initiative/ technology that has specifically taken place in 2021-2022?

It depends on the category – if you have a particular question which isn't answered by the awards categories guide, get in touch!

Can I submit as a university or industry body?

Yes, we welcome all submissions from all entities within the well intervention community

Do I need to be available to attend the awards ceremony in order to submit a nomination?

No! Whilst we warmly invite all shortlisted organisations to attend the awards ceremony to discover who will be crowned the winners, it is not obligatory. You're also welcome to send a representative in your place

What's the benefit of submitting an entry?

Global recognition from the well intervention community – we'll be informing our well intervention contacts of all the developments

HELPFUL TIPS

Include as much information as possible!

We recommend including as much information as possible relating to your submission, on both the submissions entry form and supporting resources. Your supporting resources can include:

- Reports
- Case Studies
- Videos
- Flyers
- URLs

The more information you provide - the more evidence there is to support a favourable result!

Be specific...

All nominations will be reviewed confidentially by our judging panel, so ensure you include as much specific data, case studies and the alike as possible. The more specific your entry is, the more accurately it can be judged

Submit as early as you can...

Submit before the deadline in case there are any issues with missing information, supporting documents not being accessible or incorrect attachments – that way we have enough time to contact you before sending the nomination to the judging panel. Ensure your entry includes everything you intended it to!
